# **Sector experience**




- Icknield has worked with businesses in a variety of sectors with aggregate turnover of c £7 billion





- Approximately two-thirds of Icknield's projects have been in manufacturing, services, retail or leisure

## Manufacturing sector experience









Icknield has been successful in helping clients in the manufacturing sector to rapidly improve their financial position in a number of ways including

#### Services sector experience









#### Our Services sector projects include:

## Retail sector experience









Icknield's retail experience has covered a variety of high street chains and includes:
